OldProp Solutions Inc. ("us", "we", or "our") uses cookies on fsfxpackages.com (the "Service"). By using the Service, you consent to the use of cookies.

Our Cookie Policy explains what cookies are, how we use cookies, how third-parties we may partner with may use cookies on the Service, your choices regarding cookies and further information about cookies.

What are cookies

Cookies are small pieces of text sent by your web browser by a website you visit. A cookie file is stored in your web browser and allows the Service or a third-party to recognize you and make your next visit easier and the Service more useful to you.

Cookies can be "persistent" or "session" cookies.

How OldProp Solutions Inc. uses cookies

When you use and access the Service, we may place a number of cookies files in your web browser.

We use cookies for the following purposes: to enable certain functions of the Service, to provide analytics, to store your preferences, to enable advertisements delivery, including behavioural advertising.

We use both session and persistent cookies on the Service and we use different types of cookies to run the Service:

- **Account**– we use these cookies to identify users and ensure access to users only pages.
- **Cart**– we use these cookies to build your cart and for the checkout process.
- **Functionality** – we use functionality cookies to allow us to remember your preferences.
- **Analytics** – we use cookies to help us understand our customers and the success of advertising campaigns.
- **Fraud prevention** – we use cookies to monitor and prevent suspicious activity and fraudulent traffic

Third-party cookies

In addition to our own cookies, we may also use various third-parties cookies to report usage statistics of the Service, deliver advertisements on and through the Service, and so on. To help us monitor traffic on our Sites (like many companies, we use Google Analytics to do this).

Use of pixels in emails

Our emails may contain a single, “web beacon pixel” to tell us whether, and how many times, our emails are opened and verify any clicks through to links or advertisements within the email. We use this information for purposes including:

- Determining which of our emails are more interesting to users;
- Determining users’ activity and engagement with our products and services;

The pixel will be deleted when you delete the email. If you do not wish the pixel to be downloaded to your device, you should select to receive emails from us in plain text rather than HTML via your email provider settings.

What are your choices regarding cookies
